#### **TERMS AND CONDITIONS**

# Organiser & Qualifications

- "Pakei Cashless" ("Campaign") is jointly organized by Persatuan Penjaja Petra Jaya (Company no. PPM009-13-05082016) referred to as ("Organiser") and Payments Network Malaysia Sdn Bhd (Company No.: 200801035403 (836743-D) referred to as ("Sponsor").
- 2.
