#### **TERMS & CONDITIONS**

- Make a minimum purchase of RM100 in a single receipt using a MyDebit card or DuitNow QR payment at any Lotus's outlet across Malaysia during the Contest Period. ("Participant")

#### **Contes t Period**

- 2. This Campaign will commence from 6<sup>th</sup> November 2025 at 8:00 AM until 7<sup>th</sup> January 2026 at 11:59 PM (Malaysian Time) ("Campaign Period"). Any entries received beyond the Campaign Period will be rejected and deemed invalid.
- Only transactions made at any Lotus's outlet throughout Malaysia will be accepted for this Contest.
- 4.
