

IMPORTANT NOTICE

These updated Terms and Conditions (Version 1.1) shall take effect immediately and supersede all other previous Terms and Conditions.

TERMS AND CONDITIONS

Organizer & Qualifications

1. **“MyDebit Je dengan kad ATM anda dan MENANG!” [“Contest”]** is jointly organized by 99SPEEDMART Sdn Bhd (519537-X) and Payments Network Malaysia Sdn Bhd (Company No.:200801035403(836743-D)) **[PayNet]** [collectively referred to as **“The Organizer”**].
2. The Contest is open to all MyDebit Automated Teller Machine **[“ATM”]** card members issued by financial institution in Malaysia and must be a permanent resident in Malaysia or a Malaysian citizen who has a valid identification card during the Contest Period **[“Participant”]**.
3. The Participant must be 18 years old and above and also have a valid account with any of financial institution in Malaysia and the account must be active with a good financial standing during the Contest Period until the redemption of Prizes.
4. Individuals listed below are not eligible to participate in this Contest:
 - Employees of the Organizer [including its associates, subsidiaries or related thereto] and their immediate family members [children, parents, siblings, including spouses]; and/or

 - xiv. **Week 14: 6 July – 12 July 2020 (8 winners)**
9. The Organizer reserves the right to change, extend or terminate the Contest Period at its sole and absolute discretion without any prior notice.
10. A minimum purchase of RM15 and above in all 99SPEEDMART outlets using MyDebit ATM Card (via contactless transaction) as the payment method, within the stipulated Weekly Contest Period (with a clearly printed MyDebit receipt) will be eligible to participate and be considered as a valid entry in this Contest [**“Proof of Purchase”**].
11. All payment must be made using MyDebit ATM card (via contactless transaction) to be considered as eligible entry and submit the Proof of Purchase via any of the How to Participate methods stated in Clause 12 which to be made within the Weekly Contest Period.

How to Participate

(Note: each accumulated value of RM15 = 1 serial number, RM30 = 2 serial number, RM45 = 3 serial number and so forth)(Note: serial number is for the Organizer reference/view only and will not be disclosed with the Participant)).

12.2 How to Participate (2): via MMS

- o Each valid and complete entry must contain the following information:
 - i. Take a photo of the Proof of Purchase and retain the Proof of Purchase;
 - ii. Send a photo of your Proof of Purchase along with your participation via smartphone/mobile phone using MMS to **011 3772 1809**;
 - iii. Participant will receive a reply message (Contest question, privacy notice) within 48 hours (on weekdays);
 - iv. Participant should reply to the message by agreeing to the privacy notice and provide the correct answer to **011 3772 1809**;
 - v. Every valid purchase worth RM15 and above (in a single transaction slip) will be assigned **ONE (1)** random serial number. (Note: each accumulated value of RM15 = 1 serial number, RM30 = 2 serial number, RM45 = 3 serial number and so forth)(Note: serial number is for the Organizer reference/view only and will not be disclosed with the Participant);
 - vi. Any cost/charge involved for participation via MMS shall be borne solely by the Participant.

12.3 How to Participate (3): via Whoop app (downloadable via Play Store for Android / App Store for iOS)

- i. Sign up for Whoop! App (registration for the first time only);
- ii. Click on the **“MyDebit Je dengan kad ATM anda dan MENANG!”** banner;
- iii. Take a photo of the Proof of Purchase and keep the Proof of Purchase;
- iv. Correctly answer the Contest question and provide the required information;
- v. Participant will receive an immediate acknowledgement upon submission;
- vi. By submitting entries via Whoop! app, the Participant is deemed to have read and agreed to the privacy notice set forth in this Terms and Conditions;

- vii. Every valid purchase worth RM15 and above (in a single transaction slip) will be assigned **ONE (1)** random serial number. (Note: each accumulated value of RM15 = 1 serial number, RM30 = 2 serial number, RM45 = 3 serial number and so forth) (Note: serial number is for the Organizer reference/view only and will not be disclosed with the Participant)..

13. Participant may send more than ONE (1) entry.

14. Each ONE (1) Proof of Purchase can only be used once.

15. The Participant entries will be disqualified if the same Proof of Purchase is used for more than ONE (1) time.

Winners' selection

48. The Organizer reserves the right to amend the Contest Terms and Conditions at any time at its sole and absolute discretion without prior notice. If any amendments to this Contest's Terms and Conditions are unacceptable to the Participant, they are deemed to withdraw from participating to this Contest.

49. In addition to these Terms and Conditions, any other order or rules of the Contest as stated at www.99SPEEDMART.COM.MY or otherwise, shall also bind all Participant and their participation in this Contest.
50. In the event of any inconsistency between these Terms and Conditions and any terms contained in any promotional materials for this contest, the terms contained at www.99SPEEDMART.com.my shall prevail. If there is a conflict between these Terms and Conditions with the Malay version, the English version will prevail.
