

Giant 76th Anniversary with MyDebit Contest

- b. Attach a photo of the Giant receipt & bank slip (**“Proof of Purchase”**)
**Retain the original Giant receipt and bank slip for verification purposes if you are shortlisted as a winner.*
- c. By submitting entries via WhatsApp, the participant is deemed to have read and agreed to the privacy notice set forth in this Terms & Conditions.

TERMS AND CONDITIONS

By participating in the Giant 76th Anniversary with MyDebit Contest (**the “Contest”**), you (**the “Participant”**) are taken to have read, understood and agreed to abide by and to be bound by the following terms and conditions:-

1. The Contest is jointly organised by GCH Retail (Malaysia) Sdn Bhd (Company Number: 200401028527 (667035-P)) and Payment Network Malaysia Sdn Bhd (Company Number: 200801035403 (836743-D) [PayNet] (collectively referred as **the “Organiser”**).
2. The Contest is open to all Giant customers in Malaysia who are permanent residents or Malaysians citizen aged 18 years and above (as of September 2020), with a valid identification document and must be MyDebit Automated Teller Machine [**“ATM”**] cardholder issued by the participating MyDebit financial institution in Malaysia (the “Issuing Bank”) during the Contest Period is eligible to participate in this Contest (**the “Participant”**).

2. The Proof of Purchase with a clearly printed receipts may be accepted as a valid entry and send their entry via WhatsApp or Whoop! App as mentioned above. Participant who is selected as winner is required to submit their Proof of Purchase before the redemption/fulfilment of the Prizes can be completed. Failure to do so would result in the cancellation of the Prizes won by the Participant.
