

## Shopper-Ria with MyDebit Cash Out Contest

### HOW TO PARTICIPATE: Via WhatsApp

Step 1: Purchase any products and perform cash out (withdrawal of cash at the cashier) minimum of RM50 in a single receipt using MyDebit ATM Card between 1<sup>st</sup> October 2020 to 31<sup>st</sup> December 2020 at any participating G-Ekspres/ShopSmart! outlets in West Malaysia only.

Step 2: Provide the correct answer to the question below:-

MyDebit is your ATM Card.  
True or False?

Step 3: Submit your participation and answer via **WhatsApp to +6012-337 5468**

- a. Key in required details and correct answer as follows:  
<Full Name, NRIC, Bank Approval Code, Answer>  
*\*Bank Approval Code is located at the bottom of Card Number of the original Bank slip*  
*Example: Mohamad Ali, 890917075110, 005709, TRUE*
- b. Attach a photo of the receipt & bank slip ("**Proof of Purchase**")  
*\*Retain the original Proof of Purchase for verification purposes if you are shortlisted as a winner.*
- c. By submitting entries via WhatsApp, the participant is deemed to have read and agreed to the privacy notice set forth in this Terms & Conditions.

### TERMS AND CONDITIONS

By participating in the Shopper-Ria with MyDebit Cash Out Contest ("**the Contest**"), you ("**the Participant**") are taken to have read, understood and agreed to abide by and to be bound by the following terms and conditions:-

1. The Contest is jointly organised by Jutaria Gemilang Sdn Bhd (Company Number: 201201007298 (980818-X)) and Payments Network Malaysia Sdn Bhd (Company Number: 200801035403 (836743-D)) [PayNet] (collectively referred as (**the "Organiser"**)).
2. The Contest is open to all G-Ekspres/ShopSmart! customers in Malaysia who are permanent residents or Malaysian citizens aged 18 years and above (as of October 2020) with a valid identification document and must be a MyDebit Automated Teller Machine [**"ATM"**] cardholder issued by the participating MyDebit financial institution (the "Issuing Bank") in Malaysia during the Contest Period is eligible to participate in this Contest (**the "Participant"**).
3. The Participant is required to have a valid account with the Issuing Bank and the account must be in a good financial standing and not dormant during the Contest Period until the completion of the redemption of Prizes.
4. Individuals listed below are not eligible to participate in this Contest:-
  - a. Employees of the Organiser [including its associates, subsidiaries or related thereto] and their immediately family members [children, parents, siblings and spouses] and/or

## How to Participate

1. Purchase any products (no minimum spending) and perform cash out minimum of RM50 (withdrawal of cash at the cashier) at any participating G-Ekspres/ShopSmart! outlets in West Malaysia by using the MyDebit ATM Card as a mode of payment. *For example, you can purchase any products as low as RM1 and perform the cash out (withdrawal of cash at the cashier) minimum of RM50.*
2. The Proof of Purchase with a clearly printed receipts may be accepted as a valid entry and send their entry via WhatsApp as mentioned above. Participant who is selected as winner is required to submit their Proof of Purchase before the redemption/fulfilment of the Prizes can be completed. Failure to do so would result in the cancellation of the Prizes won by the Participant.
3. Participant may submit as many entries as they wish within the Contest Period but each entry must be accompanied with the required Proof of Purchase. Each Proof of Purchase is eligible for one (1) entry only. The Organiser shall have the right to disqualify and/or reject entries where:-
  - a. the Proof of Purchase is duplicate, incorrect, unclear, torn or damaged; and/or
