

## **Shopper-Ria and MyDebit Je with your ATM Card Contest (the "Contest")**

### HOW TO PARTICIPATE (1): Via WhatsApp

Step 1: Spend a minimum of RM10 in a single receipt using MyDebit ATM Card between 1<sup>st</sup> October 2020 to 31<sup>st</sup> December 2020 at any participating G-Ekspres/ShopSmart! outlets in West Malaysia.

Step 2: Provide the correct answer to the question below:-

Step 3: Submit your participation and answer via **WhatsApp to +6012-337 5468**

a. Key in required details and correct answer as follows:

*\* Bank Approval Code is located at the bottom of Card Number of the original Bank slip*

*Example: Mohamad Ali, 890917075110, 005709, TRUE*

b. Attach a photo of the receipt & bank slip ("**Proof of Purchase**")

*\*Retain the original Proof of Purchase for verification purposes if you are shortlisted as a winner.*

c. By submitting entries via WhatsApp, the Participant is deemed to have read and agreed to the privacy notice set forth in this Terms & Conditions.

### HOW TO PARTICIPATE (2): Via Whoop! App (Available on Android Play Store/iOS App Store)

Step 1: Spend a minimum of RM10 in a single receipt using MyDebit ATM Card between 1<sup>st</sup> October 2020 to 31<sup>st</sup> December 2020 at any participating G-Ekspres/ShopSmart! outlets in West Malaysia only.

Step 2: Sign up for Whoop! App (registration for the first time only).

Step 3: Click on the "Shopper-Ria and MyDebit Je with your ATM Card Contest" banner.

Step 4: Take a clear photo of the Proof of Purchase and retain the Proof of Purchase for verification purposes if you are shortlisted as a winner.

Step 5: Provide the correct answer to Contest question and key in the required details.

## **TERMS AND CONDITIONS**

By participating in the Shopper-Ria and MyDebit Je with your ATM Card Contest ("**the Contest**"), you ("**the Participant**") are taken to have read, understood and agreed to abide by and to be bound by the following terms and conditions: -

1. The Contest is jointly organised by Jutaria Gemilang Sdn Bhd (Company No.: 201201007298 (980818-X)) and Payments Network Malaysia Sdn Bhd (Company Number: 200801035403 (836743-D) [PayNet] (collectively referred as "**The Organiser**").
2. The Contest is open to all G-Ekspres/ShopSmart! customers who are permanent residents or Malaysians citizens aged 18 years and above (as of October 2020) with a valid identification document and must be the MyDebit Automated Teller Machine ["ATM"] cardholder issued by the participating MyDebit financial institution in Malaysia (the "Issuing Bank") during the Contest Period to be eligible to participate in this Contest [the "**Participant**"].

2. A clearly printed Proof of Purchase may be accepted as a valid entry and the Participant shall send their entry via Whats App or Whoop! App as mentioned above.
3. The Participant who is selected as a winner is required to submit their Proof of Purchase before the redemption/fulfilment of the Prizes can be completed. Failure to do so would result in the cancellation of the Prizes won by the Participant.
