Terms & Conditions

1. The Store Group's "**MyDebit Je! Wave with Your ATM Card and Win**" Contest [refer as "Contest"] is jointly organized by The Store Group (252670-P) and Payments Network Malaysia Sdn Bhd (836743-D) [jointly refer as "Organiser"]
2. The Contest period starts from **3rd January 2020 until 31st March 2020 - 89 days** ("Contest Period").
3. By participating in the Contest, participants are taken to have read, understood and agreed to abide by and be bound by these Terms and Conditions of the Contest, the Data Protection & Privacy Notice as detailed below, and all amendments, additions, replacements deletions and modifications hereto ("Terms and Conditions") as may be made from time to time by the Organiser and be bound by them and abide by the decision of the Organiser.

A) ELIGIBILITY

1. This Contest is open to the cardholders of MyDebit Automated Teller Machine ("ATM") cards issued by participating MyDebit financial institutions in Malaysia ("the Participants").
2. This Participants must be a Malaysian aged 18 and above, except for the employees of the Organiser, their affiliates and their related companies, members of their immediate families (parents, spouse, son /daughter).
3. The Participants must also have an account with the participating MyDebit financial institutions which is valid, non-dormant and in good financial standing, during the Contest Period up until redemption of the Contest Prizes.
4. Participants shall comply with the eligibility requirement above in order to be an eligible participant.

B) QUALIFYING CRITERIA

1. The Participants must charge retail purchase using MyDebit ATM card via contactless transaction with a minimum purchase of Ringgit Malaysia Fifty (RM50) at The Store, Pacific ,Milimewa and Super Jimat stores (except tenanted counter), during the Contest Period.
2. Participants that purchased a minimum of RM50 in a single receipt using MyDebit ATM card via contactless transaction as a mode of payment is eligible for one (1) entry.

3. All entries must be submitted via online entry form at www.tstore.com.my/mydebit.html the latest by 31st March 2020, before 10pm. Incomplete or illegible entries will be disqualified.
4. Participants are required to provide complete details (eg Name, Mobile Number, Malaysia Identity Card (MyKad), email address and purchase outlet) in the online entry and answer Contest question correctly to be eligible to enter the Contest (“Eligible Entry”).
5. Participant also needs to upload a clear payment receipt and MyDebit transaction slip via online submission to complete the entry. The organiser reserves the rights to disqualify any uploaded image which is unclear and/or incomplete information.
6. Participants is requires to answer one (1) question being provided before online submission.
7. There is no limit to the Eligible Entry(s) entered by the Participants, however one payment receipt together with MyDebit transaction slip only valid for one (1) submission/entry.
8. Payment receipt and MyDebit transaction slip must be made/dated during the Contest Period. All the entries performed/sent/dated outside the Contest Period will be disqualified.

C) SELECTION OF WINNERS

1. Winners will be chosen through random draws from a pool of total Eligible Entry (s) performed by a random computer process after the Contest end (“Shortlisted Winners”).
2. In the event that the Organiser is unable to contact the Shortlisted Winners after three (3) attempts (i.e.no reply, telephone number not in service or no connection etc), the Organiser reserves the right to select the next Shortlisted Winners to undergo the same process. The Organiser will not be held liable in the event the Shortlisted Winners cannot be contacted for whatever reasons.
3. The Participants may submit as many entry as they wish to participate in this Contest. Except for the Instant Reward Rm10 or Rm5 Gift Voucher Prize Redemption under Clause F, each participant shall only win one (1) Prizes throughout the Contest Period, irrespective of the number of entries collected by the Organiser.
