

## **TERMS AND CONDITIONS**

### **Organiser & Qualifications**

1. **“WAVE & WIN MyDebit Je with your ATM Card!” [“Contest”]** is jointly organized by MYNEWS RETAIL SDN BHD (Company No.: 199401020616 (306295-X)) and Payments Network Malaysia Sdn Bhd (Company No.: 200801035403 (836743-D)) **[PayNet]** [collectively referred to as **“The Organiser”**].
2. The Contest is open to all MyDebit Automated Teller Machine **[“ATM”]** card members issued by financial institution in Malaysia and must be a permanent resident in Malaysia or a Malaysian citizen who has a valid identification document during the Contest Period **[“Participant”]**. The Participant must be 18 years old and above and have a valid account with any financial institution in Malaysia and the account must not dormant and must be active with a good financial standing during the Contest Period until the redemption of prizes.
  - Tier 1: A minimum purchase of RM15 and above using MyDebit ATM card at any myNEWS outlet will be eligible for maximum 1 (one) entry per receipt;
  - Tier 2: myNEWS members that make a minimum purchase RM15 and above via MyDebit ATM card at any myNEWS outlet will be eligible for maximum 2 (two) entries per receipt;

A minimum purchase of **RM15** and above (except for prepaid Top Up and bill payment) at all myNEWS outlets using MyDebit ATM Card (via contactless transaction) as the payment method, within the stipulated Contest Period (with a clear printed transaction receipt) will be eligible to participate and be considered as a valid entry in this Contest [**"Proof of Purchase"**].
10. All payment must be made using MyDebit ATM card (**via contactless transaction**) to be considered as an eligible entry and the Proof of Purchase must be submitted via any of the How to Participate methods stated in Clause 11 which to be made within the Daily and Weekly Contest Period.

- ii. Take a photo of the Proof of Purchase and keep the Proof of Purchase;
- iii. Answer the Contest question and upload Proof of Purchase;
- iv. RETAIN: Proof of Purchase (Original).
- o Participant will receive an acknowledgement message within 48 working hours of submission.
- o Each valid and complete entry must contain the following information:
  - i. Participant's particulars (as per identification card);
  - ii. Clear image of Proof of Purchase.
- o By submitting entries in this Contest, the Participant is deemed to have read and agreed to the privacy notice set forth in this Terms and Conditions.

- **How to Participate (2): via Scanning of QR Code**

28. The Organiser at its sole discretion may remove and/or disqualify any Participant and/or entries if found or suspected of cheating/hacking/tampering with the Contest submission process, the operation of this Contest or in violation of any Terms and Conditions of the Contest.
29. The Organiser reserves the right to amend the Contest Terms and Conditions at any time at its sole and absolute discretion.
30. In addition to these Terms and Conditions, any other order or rules of the Contest as stated at the website <https://ketchupps.com/contest/myNEWS> or otherwise, shall also bind all Participants and their participation in this Contest.
31. In the event of any inconsistency between these Terms and Conditions and any terms contained in any promotional materials for this contest, the terms and conditions contained at <https://ketchupps.com/contest/myNEWS> shall prevail. In the event there is inconsistency with the Malay language version, the English language version of the Terms and Conditions shall prevail.

## **Privacy Notice**

39. By participating in this Contest, the Participant give their consent to and authorisation to their respective bank to disclose to the Organiser , and authorize the Organiser to collect, store, use, process their names, masked Identification Numbers (IC) and other personal particulars **["Personal Data"]** for the purpose of running the Contest, including but not limited to announcing and publishing Personal Data and/or photos of the Participant the Organiser's website for advertising and publicity purposes.
40. By participating in the Contest, the Participant also give their consent and authorize the Organiser using a third-party service including but not limited to any MyDebit financial institution to process the Participant's Personal Data. All such third parties are contractually obliged, not to use the Participant's Personal Data in any other than way that stated herein.

41. Under the laws of Malaysia, the rights of Participant includes:
- a) The rights to withdraw consent for the use of Personal Data at any time by contacting the Organiser via its website mentioned below by providing the Organiser with the Participant's name and email address for removal of the said Personal Data;
  - b) The rights to obtain a copy of the Personal Data which the Organiser hold; and
  - c) The rights to correct inaccurate Personal Data.

43. The Organiser will take reasonable precautions to keep Participant's Personal Data secure and requires third party processors to do the same. However, the Organiser may disclose the Participant's Personal Data if required by law, search warrant, subpoena or court order.
44. Any matter to the Personal Data relating to this Contest shall be governed by and dealt with in the Personal Data Protection Act 2010 and any relevant laws in Malaysia.
