

TERMS AND CONDITIONS

Organiser & Qualifications

1. This **“Wave & Win”** Contest [**“Contest”**] is jointly organised by 7-Eleven Malaysia Sdn Bhd (Registration No: 198401008445 (120962-P)) and Payments Network Malaysia Sdn Bhd (Company No: 200801035403 (836743-D)) (PayNet) [collectively referred to as **“The Organiser”**].
2. This Contest is open to all MyDebit Automated Teller Machine [**“ATM”**] card holders issued by participating financial institutions authorising MyDebit services in Malaysia. The mentioned card holders must be a permanent resident in Malaysia or a Malaysian citizen who is 18 years of age and above and has a valid identification document during the Contest Period [**“Participant”**]. By joining this Contest, the Participant acknowledges that the Contest is in no way sponsored, endorsed, or administered by, or associated with Samsung, Dyson and/or any other brands, unless stated otherwise.
3. The Participant must also have a valid account with any of the mentioned financial institution in Malaysia and the account must be active with a good financial standing and not dormant during the entire Contest Period until the completion of the redemption of prizes.
4. Individuals listed below are not eligible to participate in this Contest:
 - Employees of the Organiser [including its associates, subsidiaries or related thereto] and their immediate family members [children, parents, siblings, including spouses]; and/or
 - Representatives, employees and/or the advertising agencies or promotional agencies of the Organiser [including its associated and related companies], and their immediate family members [children, parents, siblings, spouses].

Contest Period & Entry Criteria

2. Entries received beyond Contest Period will be deemed invalid and will be forfeited.
3. The Organiser reserves the right to amend, extend or terminate the Contest with notice.
4. For the monthly submission, the Organiser must receive the submission of entries on or before 11:59 PM (Malaysian Time) of the last date of each Monthly Period as tabulated below. Only entries with transaction receipt using MyDebit ATM card as a mode of payment will be accepted for this Contest. The said transaction receipt will no longer be valid for submission for the following month. As an example, transaction receipt dated 1st October 2022 (Month 1 of the Monthly Period) must be submitted on or before 31st October 2022, 11:59 PM (Malaysian Time).

A minimum purchase of RM25.00 and above in a single receipt at any 7-Eleven Malaysia outlets with the usage of MyDebit ATM card as a mode of payment made within the Contest Period (with a clear printed and successful transaction receipt) [**“Proof of Purchase”**] with one serial number assigned, may be entitled to be regarded as One (1) valid entry. Participant who is selected as winner [**“Winner”**] is required to submit their Proof of Purchase (original) before the redemption/fulfillment of the prizes can be completed. Failure to do so would result in the cancellation of the prizes won by the Winner. Note: Serial number is for Organiser’s reference and will not be shared with Participant.
6. Only clear snapshot of the Proof of Purchase indicating the products, receipt number, purchase date, purchase value, outlet name, outlet location and MyDebit payment details will be accepted. No alteration of Proof of Purchase in any form is allowed.

How to Participate

1. Each entry must be accompanied by a Proof of Purchase made during the Contest Period at any 7-Eleven Malaysia outlets. Entry must be submitted with the following way:

- **Each complete entry must** contain the following information, failing which the entry will automatically be disqualified without notice:
 - I. Take a clear photo of the Proof of Purchase and keep the Proof of Purchase (original);
 - II. Scan the QR code at any 7-Eleven Malaysia stores or any official communication channels to submit your entry;
 - III. Attach the photo of your Proof of Purchase, fill in the details such as full name, identification card number (MyKad), contact number, email address, receipt number, address and state/location of purchase and answer Contest’s question correctly.
 - IV. Click “Submit” to submit your entry.
 - By submitting the entry in this Contest, the Participant is deemed to have read and agreed to the privacy notice set forth in the Terms and Conditions herein.
2. Participant may send more than ONE (1) valid entry. Each ONE (1) Proof of Purchase with minimum purchase of RM25.00 and above in a single receipt made using MyDebit ATM card is eligible as ONE (1) valid entry regardless the amount spent. Each Proof of Purchase can only be used once. Participants’ entries will be disqualified if the same Proof of Purchase is used for more than ONE (1) time.
 3. Each Participant and/or Winner is only eligible to win a maximum of ONE (1) prize throughout the Contest Period.
 4. Winner must claim their prizes on the specific date provided by the Organiser or within EIGHT (8) weeks after being notified by the Organiser (via e-mail or any other communication channels), unless advised otherwise. All Shortlisted Winners will be informed via e-mail, Short Message Service (SMS) and/or any other available communication channels based on the contact information supplied during their submission process. A simple Contest question will also be asked during the submission process. Shortlisted Winners will be required to answer the question correctly in order to be eligible to win the prize. 4. The Organiser reserves the right to amend the Contest Terms and Conditions with notice.

Privacy Notice

Data and entries. All such third parties are contractually obliged, not to use the Participant's Personal Data in any other than way that stated herein.
