

TERMS AND CONDITIONS

Organiser & Qualifications

1. **“Win RM100 with MyDebit” (“Contest”)** is organized by Lotuss Stores (Malaysia) Sdn Bhd (No. Syarikat: 200001018812 (521419-K)) (**“The Organiser”**) in collaboration with Payments Network Malaysia Sdn Bhd (**“PayNet”**) (Company No.:200801035403 (836743-D)) (**“Prize Sponsor”**).
2. The Contest is open to all MyDebit Automated Teller Machine (**“ATM”**) card members issued by a financial institution in Malaysia. The MyDebit ATM card holder must be 18 years old and above and a Malaysian citizen or a permanent resident with a valid document/personal identification during the Contest Period (**“Participant”**).
3. The Participant must have a valid account with any active financial institution, not dormant and must be in good financial standing during the Contest Period as well as up to the redemption of prizes.
4. Individuals listed below are not eligible to participate in this Contest:
 - Employees of the Organiser and Prize Sponsor (including its associates, subsidiaries or related thereto) and their immediate family members (children, parents, siblings, including spouses); and/or
 - Representatives, employees and/or the advertising agencies or promotional agencies of the Organiser and Prize Sponsor (including its associate and related companies), and their immediate family members (children, parents, siblings, spouses).

Contest Period & Entry Criteria

1. This Contest will commence from **1 August 2024 until 6 October 2024 at 11:59 PM** (Malaysian Time) (**“Contest Period”**). Any entries received beyond the Contest Period will be rejected and deemed invalid.
2. A minimum purchase of RM150 and above (in a single receipt/transaction) at all Lotus's physical outlets using MyDebit ATM card as the payment method, within the stipulated Contest Period (with a clearly printed transaction slip) will be eligible as a valid entry for this Contest (**“Proof of Purchase”**).
3. The Participant may send more than ONE (1) entry. Each ONE (1) transaction slip (with a payment of RM150 and above using a MyDebit ATM card as mode of payment) is eligible for ONE (1) entry only and can only be used once. Participants' entries will be forfeited if the same transaction slip is used for more than ONE (1) time.
4. Entries received beyond the stipulated Contest Period will be deemed invalid and will be forfeited.

5. The Organiser reserves the right to amend, extend or terminate the Contest/Contest Period without prior notice.
6. A Participant who has been selected as a winner ("**Winner**") might be required to submit their physical Proof of Purchase before the prize redemption/fulfillment can be completed. Failure to do so would result in the cancellation of the prize(s) won by the Participant.

 - i. A photo of the Proof of Purchase (RETAIN: **PROOF OF PURCHASE (original)**).
 - ii. Answer the Contest question and provide the participant's required information.

- Participants will receive a reply message (with information relating to privacy notice, contest question, participant's required information).
- By submitting entries via WhatsApp, the Participant is deemed to have read and agreed to the privacy notice set forth in these Terms and Conditions.
- Note: Each valid Proof of Purchase RM150 and above (in a single transaction slip) will be assigned **ONE (1)** serial number per entry (one entry per transaction slip regardless of the amount spent). (Note: serial number is for the Organiser reference/view only and will not be disclosed to the Participant).

- **How to Participate (2): via Whoop app (downloadable via Play Store and App Store)**

- Register in Whoop App (one-time registration).
- Click on Lotus's "**Win RM100 with MyDebit**" contest banner. Each complete and eligible entry must contain the following information:
 - i. A photo of the Proof of Purchase (RETAIN: **PROOF OF PURCHASE (original)**).
 - ii. Answer the Contest question and provide the participant's required information.
- By submitting entries via Whoop! app, the Participant is deemed to have read and agreed to the privacy notice set forth in these Terms and Conditions.
- Note: Each Proof of valid Purchase RM150 and above (in a single transaction) submitted will be assigned **ONE (1)** serial number per entry (one entry per transaction slip regardless of the amount spent). (Note: serial number is for the Organiser reference/view only and will not be disclosed to the Participant).

8. Participants are required to provide a valid identification document (Malaysian identification card) and Proof of Purchase during or prior to prize redemption for Winner's verification process. Proof of Purchase which is faded, damaged, etc. will be deemed invalid and will be disqualified from the Contest.
9. Winner will be selected based on the following process:
 - o The serial numbers allocated to each day's qualified entries will be tabulated to derive the total serial number which will then be divided by sixty-seven (67) to derive the daily winning serial numbers. In the event of numbers with decimal values, the winning serial numbers will be rounded down to the nearest whole number that results after the division.
 - o For example: If the daily qualified entries serial numbers total up to 600, these 600 serial numbers will be divided by 67 which equals 8.96 which will be rounded down to 8. The multiplier number in this case is 8. Sixty-seven (67) Participants of the day assigned with multiples of 8 i.e. 8, 16, 24, 32, 40, 48, 56, 64 and so forth will be selected as the daily prize winners.
 - o In the event of a repeat Winner, the serial number before the multiplier number will be declared as the Winner of the said daily prize. For example, if position 24 (of the serial number) is a repeat winner, therefore serial number 23 will be declared as the winner.

After the end of Contest Period, in the event the winners cannot be contacted after three (3) attempts for three (3) consecutive working days (during working hours, Monday to Friday), the Organiser reserves the right to forfeit the Winner's eligibility and shall select the next qualified Participant (based on the serial number before the multiplier number) as the Winner at the absolute discretion of the Organiser.

Contest Prizes & Redemption

2. By participating in the Contest, Participant consents and authorizes the Organiser to use a third-party service including but not limited to any MyDebit financial institution to process the Participant's Personal Data. All such third parties are contractually obliged, not to use the Participant's Personal Data in any other than way that stated herein.

3. Under the laws of Malaysia, the rights of Participant includes:
 - a. The rights to withdraw consent for the use of Personal Data at any time by contacting the Organiser at the contact details mentioned below by providing the Organiser with the Participant's name and email address for removal of the said Personal Data;
 - b. The rights to obtain a copy of the Personal Data which the Organiser hold; and
 - c. The rights to correct inaccurate Personal Data.

6. Any matter to the Personal Data relating to this Contest shall be governed by and dealt with in the Personal Data Protection Act 2010 and any relevant laws in Malaysia.
